Pursuant to the provisions of the Colorado Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Cedar Springs Improvement Assoc.

The following paragraphs will be added to Paragraph Third of the original Articles of Incorporation: The corporation shall have the power to enforce the covenants; collect pro-rata charges for maintenance; maintain, preserve, improve and repair the roads within the subdivision; enforce any and all building and land use restrictions which may be imposed on or against any of the property in the subdivision; maintain, manage and control all common areas and improvements located in the subdivision; and to levy and collect assessments as established by the Board of Directors.

Paragraph Fourth of the original Articles of Incorporation are hereby amended and stated as follows: The address of the initial registered office of the corporation is 759 Palisade Mountain Drive, P.O. Box 8, Drake, Colorado 80515 and the name of its initial registered agent at such address is Donald G. Wagner.

Paragraph Sixth of the original Articles of Incorporation are hereby amended and stated as follows: The number of directors constituting the Board of Directors of the corporation is five. There should be a president, vice-president, secretary, treasurer, and director at large.
